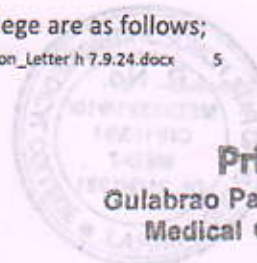

Important Note:

- 1) This Conditional Continuation / Extension of affiliation is issued for the A.Y. 2024-2025 subject to the permission of NCH / Govt. of India / Department of AYUSH, New Delhi. Further, if the permission is declined by the said authorities, this Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCH / Govt. of India/ Department of AYUSH New Delhi.
 2) The admission shall be done through the Competent Authorities only.
 3) The Conditional Continuation / Extension of affiliation is given subject to the final verdict of the Hon'ble Court / Decision by NCH / State Govt. / Competent Authority w.r.t. the Irregular admissions dun during the A.Y. 2019-20.
