Sir/Madam,

In compliance to the letter dated 09.09.2024 of Medical Assessment and Rating Board (MARBH) referred above, an affidavit has been received from the Principal/Authority of Gulab Rao Patil Medical College.

The College has applied permission for sanction for BHMS course with 100 seats for the Academic Year 2024-25 through online portal. MARBH examined the profile of the college so as to assess the compliance to minimum essential standards to be fulfilled as per the regulations enforce at the time of calling applications and other provisions of NCH Act 2020. On careful examination of the report dates following shortfalls have been observed:

1). Hospital Details


- X-Ray, ECG, USG registers are not available for verification.
- Lab investigation reports should be maintained properly.

2). Miscellaneous

- Aadhar enabled biometric attendance system(AEBAS) is not implemented. This may enabled within a period of one month.

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number, etc. Diagnosis of the case shall be recorded as per ICD 11 criteria. All follow-up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation as per Homoeopathic Principles and made available in the Medical Record Room for academic purposes of students and follow up of patients.

Therefore, considering the above shortfalls and facilities available, MARBH has decided to issue **Conditional Permission to Gulab Rao Patil Medical College, 795, Gulab Rao Patil Education Camps, Near Govt Milk Dairy, Distt, Sangli, Miraj-416410 Maharashtra with intake capacity of 100 seats in BHMS course during A.Y. 2024-25.**

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made for NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by respective counselling authority of State/UT Govt. as designated by Central Government/NCH for A.Y2024-25 and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of the State/UT.

The category wise list of the selected candidates must be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year, if college is found deficient in compliance to MSR 2013 anytime during the academic year.
