(ii) **Settlement of advance(s) / dues of any section of the University including affiliation fees if pending with the College and any other deficiency observed by any regulating authority, please submit within 03 (three) months, otherwise, no action will be taken on teacher's proposal for approval / PG Recognition received from your College.**

**Important Note:**

- 1) This Conditional Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of National Commission for Homoeopathy / Government of India/Department of AYUSH, New Delhi. Further, if the permission is declined by the said authorities, this Conditional Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1<sup>st</sup> Year of the course until receipt of permission of the National Commission for Homoeopathy / Government of India /Department of AYUSH, New Delhi.
